NOTICE OF RACE

- 1. <u>RULES</u> The Regatta will be governed by The Racing Rules of Sailing.
- 2. <u>ADVERTISING</u> Advertising will be restricted to Category A.
- 3. <u>ELIGIBILITY</u> This event is open to all members of FSSA.
- 4. <u>REGISTRATION</u> Completed entry forms must be received by June 17th, 2006 or be subject to a \$20 late fee. A registration form is included with this Notice of Race. Send entry forms to: **Cedar Point Yacht Club, Attention Flying Scot Districts, 1 Bluff Point, Westport, CT 06880**. Please make checks payable to **FS Fleet 177**. On site registration will be available at CPYC on June 23rd from 1700 1900 or on June 24th from 0800 1000.
- 5. <u>FEES</u> The entry fee is \$65 if received by June 17th. Entries received after that date must include a **\$20 late-fee**. The entry fee includes refreshments after sailing, 2 Saturday night dinners, continental breakfast on Saturday and Sunday morning and lunch on Sunday. Additional Saturday dinners may be purchased for \$15.

- 7. <u>MEASUREMENT</u> Boats and sails must conform to the Official Plan. Each boat must carry equipment required by FSSA Article S-V.2 Restrictions and Coast Guard safety regulations.
- 8. <u>SAILING INSTRUCTIONS</u> Sailing Instructions will be available at registration and at the Skipper's meeting.
- 9. VENUE The racing area will be approximately 2-3 miles southeast of the mouth of the Saugatuck River.
- 10. <u>COURSES</u> The courses will be defined in the Sailing Instructions.
- 11. <u>SCORING</u> The Low-point Scoring System of Appendix A2 will apply. Five races are scheduled, of which one shall be completed to constitute a series. Each boat's total score will be the sum for all races (no throw-outs).
- 12. <u>PRIZES</u> This is a Flying Scot sanctioned event, the district trophy may only be won by a district member. Prizes will be awarded to the top five boats.

DIRECTIONS TO THE CLUB (From North and South)

Connecticut Turnpike (I-95) to exit 17 (Westport). At the end of the ramp, turn right onto Route 136. Go about 1.5 miles on Route 136. Turn left on Duck Pond Road. Take your first left on Harbor Road. Follow Harbor Road to the stop sign before one-way bridge. **DO NOT CROSS BRIDGE WITH TRAILER'S OR SUV'S.** Turn right just before bridge onto Canal Road. Go 0.25 miles to the end and turn left onto Cockeone Drive. Take your first left onto Spriteview Avenue and then the first right onto Crossway. This will take you to the club.

CPYC shares Bluff Point in a residential neighborhood populated by many young children and pedestrians. **Please be mindful of the 15 mph speed limit and obey all stop signs on Saugatuck Island.** The extra minute will make your drive safer, more pleasant and benefit our relations with Island residents.

I understand that serious accidents occasionally occur during sailboat racing, and that participants in sailboat racing occasionally sustain mortal or serious personal injuries and/or property damage as a consequence, and I knowingly assume all of the risks of sailboat racing. I agree that this waiver is binding on my heirs, representatives, successors and assigns.
